2026 Student Resource Scheme

In 2026, Canungra State School will continue to operate a Student Resource Scheme (SRS) for all students in Prep to Year 6. Whilst the cost of providing instruction, administration and facilities for the education of a student is met by the state, a parent/guardian is directly responsible for providing the student with workbooks and other resources. **The 2026 SRS will cost \$60.00 per student, families with 3 or more students will have the payment capped at \$180.00.**

Purpose of the SRS:

- Provide parents with cost-effective alternative to purchasing resources
- The SRS is endorsed by the P&C yearly, but managed by the school & operates within the guidelines and policies of the Department of Education

Participation in the SRS:

- Participation in the scheme is voluntary
- Parents who choose to participate in the scheme will be required to return the participation agreement form (new families or exiting family who have not completed a form) and pay the yearly fee of \$60.00

Benefits of the SRS:

- The SRS ensures that students have the required online resources and text books for their education when the school year commences
- The SRS saves parents/guardians time and money in sourcing appropriate materials provided through the scheme
- Every child has exactly what is needed
- Teachers have flexibility with resources
- Students have ready access to teacher prepared workbooks and online curriculum resources

Payment options:

- Full payment: Due by Friday 27th March 2026
- Payment plan: Agreement made as per payment plan by 20th February 2026 (Centrepay, Cash, EFTPOS, Bpoint or Qkr app)
- For families experiencing financial hard-ship please contact the school to discuss options with the principal.

Once a participation agreement form is completed, SRS resources will be issued to the student. Payment can be made at a later date; students will have full access to online programs and text once the forms are received.

Please ensure you read and understand the terms and conditions on the back of the participation agreement form. paying close attention to the Payment Arrangements, Debt Management and Financial Hardship sections

PLEASE NOTE – PARENT/GUARDIANS WILL ONLY BE INVOICED FOR THE 2026 SRS ONCE AGREEMENT FORMS ARE RETURNED, PRE-PAYMENTS ARE WELCOME HOWEVER PAYMENTS ARE NOT BEING TAKEN IN THE FINAL 2 WEEKS OF SCHOOL FOR 2025
